The General Federated Woman's Club of Morristown is community service 501 (c) (3) organization. The club won a GFWC-Arizona award in 2006 for working with the Maricopa County Library District (MCLD) to get bookmobile service started as a first step toward getting a permanent library for our underserved and growing population and for ongoing sponsorship and participation in literacy programs in the local schools. In May 2008, GFWC opened an MCLD sponsored Free Lending Library in the Old Main building on the Morristown Elementary School's campus. Negotiations continue with MCLD to get a full service library for residents of communities along the Highway 60 corridor from Wittmann to Morristown.
